Ms. Pontious next gave an update on the small systems acquisitions. She noted that the Durham Village Homeowners Association has scheduled a membership meeting on April 1, 2015, for the residents' ratification of the proposed water system sale. She reported that the term sheet for the Logan Square water system purchase has been signed by both parties, and that the formal Agreement of Sale is being prepared at this time.

# **Engineers Report:**

Mr. Heydt reported that all the required documents have been received from Joao & Bradley and he asked for a motion for North Wales Water Authority Board, by its authorized officers, to execute Bid Contract 530-15-16 for the Merrybrook Water Main Replacement Project awarded to Joao & Bradley Construction Company, Inc. The Notice to proceed will then be sent out to the contractor.

### Operations Report:

Mr. Fisher reviewed the monthly operating report, noting the following:

Due to extreme winter weather there was a higher than normal amount of frozen water meters throughout the winter months, with 21 such incidents reported in February. He noted that almost all of these situations were within occupied buildings wherein the meter was not insulated properly, or was located in an area that was not sufficiently heated.

He noted that new water services inquiries for North Wales Borough has significantly increased over prior years.

He reported that the Merrybrook water main replacement project is now underway

He reported that a very successful meeting was held with PennDOT officials, to review the upcoming West Walnut Street paving project. He noted that PennDOT would be starting the paving overlay project at Route 63, and will be coordinating with us while we complete our water and sewer line replacements, in advance of the paving work. He noted that the PennDOT representatives said that they would be taking care of installing and/or replacing handicap ramps at the intersections, as required.

He reported that in order to proceed with preparation of specifications for the Blue Bell tank refurbishment, an in-tank diving inspection will be needed and that he will engage the services needed to complete this assignment.

# Bills & Requisitions Approval:

Mrs. Lezoche noted that there was an annual payment for the new Rapid Response public notification system in the bills list, and that there were no other payments or activities out of the ordinary within the bills listings. She recommended and requested approval to pay all invoices, process all refunds, and to transfer and/or requisition funds, as presented.

### Executive Directors Report:

Mr. Bender reported that he had met with the new North Wales Borough Manager to discuss the West Walnut Street paving project, noting that additional meetings will be needed to discuss parking and local traffic issues resultant of the project.
