# MTBE: Cleaning the air or contaminating the water?

Recent media scrutiny has exposed the public to a problem that the drinking water industry has been contending with for many years. The problem is water contamination from MTBE. Reports have repeatedly told horror stories of soil and water contamination all across the United States.

MTBE, or methyl tertiary butyl ether, is a member of a group of chemicals commonly known as fuel oxygenates. They are added to gasoline to increase its oxygen content, thus making it burn more cleanly and efficiently. MTBE has been used in gasoline since 1979 as an octane enhancing replacement for lead, and in higher concentrations since the Clean Air Act of 1990 to enhance combustion and reduce tailpipe emissions. Although there are other substances available such as ethanol, MTBE is the most commonly used fuel oxygenate.

The use of MTBE has indeed yielded clean air benefits. Unfortunately, the main cause of contamination, leaking underground gasoline storage tanks, has resulted in MTBE being detected in groundwater supplies coast to coast. Small gasoline spills and improper disposal are also sources of groundwater contamination. Only a few gallons of gasoline containing MTBE could contaminate a large volume of water.

Many chemicals in gasoline, including MTBE, may be harmful in drinking water. The US-EPA has classified MTBE as a potential human carcinogen. It is highly soluble and can travel faster and farther in water than any other gasoline component. These factors alone have generated widespread concern that drinking water supplies and human health may be at risk.

The North Wales Water Authority realizes that MTBE contamination presents a real and growing threat to our drinking water resources. The large clean up costs and possible health risks associated with MTBE contamination demand immediate focus on ways to prevent future problems and remediate those that already have occurred. The Authority has been routinely monitoring MTBE for many years and in those areas impacted by gasoline spills or releases, has voluntarily increased monitoring frequencies. MTBE has never been detected in any groundwater supply that is used by the Authority.

Protecting vital groundwater supplies that are in constant jeopardy is a fundamental issue for the North Wales Water Authority. We realize that while air quality standards must continue to be improved, it should not be at the expense of our drinking water resources or the health of our customers.

### YOUR QUESTIONS **ANSWERED**

Question: How can I protect myself from water utility worker impersonators?

#### Answer:

Due to the recent events that have occured in our area with individuals posing as water utility workers, we are offering you the following information in respect to the North Wales Water Authority:

- 1. Ask for company identification. Every employee of the North Wales Water Authority has an identification card. The card includes a picture of the employee along with our company logo (located on the front page of this newsletter).
- 2. All of our company vehicles have our logo on the side which includes the company name and the Water Wizard. The vehicles are either white or blue.
- 3. If you are unsure that the individual is an employee, please call our office at 215-699-4836 and confirm the individual with one of our customer service representatives.
- 4. Generally, if we need access to the inside of your home, we make an appointment with you.
- 5. If there is a water main break, we will simply knock on your door to notify you, but we do not need to go inside your home.
