Mr. Bender reported that all approvals have been received from Warrington Twp. for the 1553 locations and that the site work will be started by Wolverine construction per Mr. Gundlach's office. We are working on the bid specs for the new building and could be ready to settle on the property in December and have the new building bids ready for advertise then.

The Elm and Swartley Street and Pennsylvania Ave project is coming along and we are anticipating that we will finish the project and pave the roads in the spring. Mr. Bender said that he will contact the Borough Manager and recommend only temporary patching and repairs at this time as the as the street will be dug up for the Authority sewer pipe replacement program, prior to repaving work next spring.
