Public Comment:

Ms. Linda Kennedy of 103 Palace Court, Chalfont, PA. (New Britain Township) was present to discuss a suspected water service leak at an adjacent townhome, causing water to leak into her basement and a recurrent activation of her sump pump, causing water accumulation upon the rear year HOA controlled open space. Mr. Bender acknowledged receipt of her letter of October 10th, advising that the Board had received a copy, as well as copies of the letters he sent to her and the neighbor, requesting immediate

action by the neighboring homeowner to remedy the situation. Mr. Bender then advised all present that the suspected leak appears to be located UNDER the concrete slab in the neighboring townhome, and that the service line (leaking or not) is privately owned and all maintenance and repair is the responsibility of the private property owner. He further stated that even if the service line was leaking outside of the home and in HOA open space, it would still be the responsibility of the property owner to repair.

Lastly, Mr. Bender reported that NWWA staff have been out to the site in an attempt to help locate the problem - as a courtesy and extra customer service and advised Ms. Kennedy that although we could not legally assume responsibility for the leak, we would continue to assist as best possible.

No official Board action was requested or taken on this matter.

Executive Directors Report:

Mr. Bender noted that he would be attending his first meeting at the Delaware River Basin Commission subcommittee, on November 14, 2024, representing the Authority.

He next updated the Board on the required notifications that we need to send to about 17,000 customers related to the PaDEP Lead & Copper service line program and mandate. We will be notifying customers by postcard and email, including information about the program and where they can locate additional information, including the NWWA website.

Mr. Bender noted that at the next meeting in November, he will present five Resolutions authorizing Grant Application for the following projects:

- Construction Vehicles up to \$100,000.00
- Security Updates at Main Office complex and Montgomery Ave warehouse up to \$67,000.00
- Ft Washington Tanks repairs and painting up to \$1,000,000.00
- Maryland Drive tank repairs and painting up to \$794,000.00
- Installation of fixed base Meter Reading System amount TBD (estimated as up to \$1,000,000.00)

Mr. Bender then updated the Board on the proposed 2025 budget and rate increases, noting that the average residential customer receiving both water and sewer services from NWWA would pay about 40-50 cents more per day, noting the 1.5 million dollar increase in electrical expense, and other significant operating expense increases.
